AOB | In response to a query regarding International student caps, it was advised that: Universities and providers of services were collectively lobbying hard regarding the significant impact Offshore teaching was not forming a strong part of the alternatives being considered currently, with a focus on growing domestic load A strategic focus on international partnerships could put the College on a good footing to develop offshore teaching, should that be an agreed way forward | |
| | The Dean (Education) asked members to remind and encourage colleagues to continue the process of contacting students in the week before census to make sure they understood their options. The P&C Coordinator advise that changes to the casual and fixed term employment conditions were being monitored by P&C, and Universities were currently exempt, though noting that staff should not be offered fixed term contracts where the work could reasonably be considered to be continuing. It was noted that any changes would impact the whole University sector. | |
