

#### **OVERVIEW**

The Register of HDR Supervisors is a new module delivered to Inspire, the HDR candidature management system used at Flinders University.

This guide explains how a potential or current HDR Supervisor can use Register of HDR Supervisors module and answers some common questions.

- register for the Register of HDR Supervisors or apply for an exemption online
- manage their compliance with the Register of HDR Supervisors
- track completion of the HDR Supervisor Development Program

**ECR status** gives a researcher a five year exemption from the PhD award date to override the research activity requirement, noting that if a researcher is research active according to the <u>HDR Supervisor</u> <u>Procedures</u>, s.6, that will prevail. If a researcher falls below the research active threshold within the five year exemption, the exemption will be activated until the end-date.

The second part of the form covers **exemptions other than** ECR (please refer to Question 3 for more details). If you do not wish to apply for an exemption, choose **No** option, move on to read the Declaration, sign the form and submit it.

Once the form has been submitted, you will receive a notification email.
